Week in Review

Legislators kicked off the week with a relatively busy Monday, with eight budget subcommittee meetings, two standing committee meetings in the Senate, and a handful of bill subcommittee meetings in each chamber, and the week only got busier from there. Committee work began to ramp up this week, with over 100 bills passed through standing committees. There are now just two weeks until the first funnel, when bills must make it through committee to stay alive. Throughout the week, 146 bill subcommittee meetings were held. There was still no floor action in either chamber this week.

The Governor's policy agenda took center stage at the capitol this week. The Governor released a number of her priority bills, and bill subcommittee meetings were held for two of her priority bills. The bill at the forefront of discussion was the Governor's proposed area education agency (AEA) bill, HSB 542 in the House and SSB 3073 in the Senate. On Monday, the Governor released her recommended changes to the AEA bill that she proposed early this session. The bill initially received pushback from interested parties, and the Governor had indicated that she would take the feedback into account and release an amendment. The amendment can be found here. Subcommittees for this bill were held in both the House and the Senate on Wednesday. The House subcommittee did not advance the Governor's bill to the full committee, stating that more time and further conversations were needed before making changes to lowa's special education system. However, the Senate subcommittee did pass the bill on to the full Education committee while recommending that changes be made.

On Tuesday, a bill subcommittee was held for <u>SSB 3113</u>, the Governor's priority bill on foreign ownership of farmland that she previewed during her Condition of the State speech. The bill was advanced to full committee with support of all three members of the subcommittee. On Wednesday, the bill passed out of Senate Agriculture 16 to 0.

More of the Governor's anticipated priority bills were introduced this week, including the following:

- <u>SSB 3140</u> and <u>HSB 643</u>, which expand postpartum Medicaid coverage from 60 days to 12 months and change income eligibility levels for pregnant women and infants under the Medicaid program. A bill subcommittee meeting is scheduled for early next week in both the Senate and the House.
- HSB 642, which allows pharmacists to dispense self-administered hormonal contraceptives to adult patients.
- SSB 3119, which primarily makes changes to state executive agencies' rulemaking process.

Income tax reduction proposals also received attention this week. The Governor's proposal, <u>HSB 543</u> and <u>SSB 3038</u>, was released the first week of session and would lower lowa's individual income tax to 3.65% for 2024 and 3.5% starting in 2025. This week, House and Senate Republicans released an income tax plan that differs slightly from the plan proposed by the Governor.

The House and Senate proposal, <u>SSB 3141</u>, still seeks to lower individual income taxes, eventually to 0%, but does so on a different timeline than the Governor's plan. The plan would expand on the personal income tax cuts passed in 2022, which reduced lowa's income tax rate to a flat 3.9% by 2026. Under SSB 3141, the tax rate would reduce to 3.775% in 2026 and to 3.65% in 2027. In future years, further individual income tax reductions would be paid for through moneys put into a newly created "lowa Taxpayer Relief Trust," which would receive an initial \$2.6 billion transfer from the existing Taxpayer Relief Fund. The balance and moneys earned from interest in the trust would be transferred to a newly created "Income Tax Elimination Fund" and dedicated to individual income tax reductions until the rate reaches 0%.

Bills on the Move

Bill subcommittee movement

SSB 3114 - More Options for Maternal Support (MOMS) program

 Allows the HHS to either administer the MOMS program directly through contracts with providers of pregnancy support services, or through a program administrator selected through a request for proposal (RFP) process.

HSB 617 - Transport of patients to mental health access centers by ambulance

- Allows an ambulance services program to transport a person experiencing a mental health crisis to a mental health access center.
- Requires the HHS to authorize payments to service programs for such transport in amounts similar to payments authorized for the transport of persons to hospital emergency departments.

Latest Action: Bill subcommittee meeting held on Wednesday. Passed on to House Health and Human Services.

HF 71 - Insurance coverage for diagnostic breast cancer examinations

- Requires an insurance policy, contract, or plan providing for third-party payment of health or medical expenses to provide coverage for diagnostic breast cancer examinations.
- Provides that this coverage cannot be less favorable than coverage a health carrier offers for screening mammograms, and that cost-sharing cannot be imposed that is greater than the cost-sharing imposed for a screening mammogram.

Latest Action: Bill subcommittee meeting held on Wednesday. Passed on to House Commerce.

SSB 3095 - DIAL, confidentiality of information and records, dependent adult abuse

- Provides that DIAL may provide county attorneys, law enforcement agencies, and licensing boards with the department's evaluation materials and findings related to a report of dependent adult abuse.
- Changes the timing for DIAL notification to a facility or program that employs a
 perpetrator of founded dependent adult abuse when notice of investigative
 findings has been issued.

Latest Action: Bill subcommittee meeting held on Thursday. Passed on to House Judiciary with the recommendation of an amendment.

SF 2092 - Rural lowa primary care loan repayment program

 Allows radiologists to participate in the rural lowa primary care loan repayment program administered by the College Student Aid Commission.

Latest Action: Bill subcommittee meeting held on Thursday. Passed on to Senate Education. The companion bill (HF 2110) passed out of subcommittee last week.

HF 2199 - Health care employment agencies

 Requires the HHS to annually establish a statewide maximum allowable charges schedule applicable the following calendar year to nursing services

 Requires each separate location of an agency registered in lowa to utilize and comply with the charges schedule.

Latest Action: Bill subcommittee meeting held on Thursday.

HSB 638 - Contracts and payments for dental care service plans

- Permits a contracting entity to grant third-party access to a network contract, or to a dental care provider's dental care services or contractual discounts provided pursuant to a contract, if certain conditions are met, as outlined in the bill.
- Prohibits a contracting entity from canceling, terminating, or refusing to form a contractual relationship with a provider that chooses not to participate in thirdparty access.
- Prohibits a dental care service plan from requiring payments to be made to a
 provider by virtual credit card payment, and specifies requirements regarding
 various payment methods.

Latest Action: Bill subcommittee meeting held on Thursday. Passed on to House Commerce with the recommendation of an amendment.

HSB 616 - Epinephrine auto-injectors

 Allows a pharmacist to order and administer an epinephrine auto-injector to an adult without a prescription.

Latest Action: Bill subcommittee held on Thursday.

HSB 198 - Work Without Worry program

- Creates a Work Without Worry program under the Medicaid program for employed individuals with disabilities who are at least 16 years old.
- Specifies criteria for coverage under this program.

Latest Action: Bill subcommittee held on Thursday. Passed on to House Health and Human Services with the recommendation of an amendment.

Standing committee movement

SSB 3096 - Ambulatory surgery centers

- Defines "ambulatory surgical center" (ASC) differently relative to the Health Facilities Council and Certificate of Need.
- Exempts cosmetic, reconstructive, or plastic surgery services provided in an ambulatory surgical center from the applicability of Certificate of Need requirements.
- Modifies application requirements for an ASC license.

SSB 3012 - Medical income assistance trust fees

• Increases the amount that may be paid or set aside each month for necessary trust expenses without court approval for beneficiaries whose total monthly income is less than 125% of the average statewide charge for nursing facility services to a private-pay resident of a nursing facility from \$10 to \$50.

Latest Action: Passed out of Senate Judiciary 17 to 0 on Tuesday.

HF 626 - Continuity of care and nonmedical switching

 Prohibits limiting or excluding prescription drug coverage for a medically stable covered person if certain factors apply.

Latest Action: Bill subcommittee meeting held in the Senate on Monday. Passed out of Senate Commerce 16 to 0 on Tuesday.

<u>HSB 501</u> - Limitations on activities related to paid claims under Medicaid Latest Action: Passed out of House Health and Human Services 21 to 0 on Tuesday.

<u>HF 2064</u> - Disclosure of a minor's electronic protected health information to a legal guardian

Latest Action: Passed out of House Health and Human Services with an amendment 21 to 0 on Tuesday.

HSB 589 - Ambulatory surgery centers

Latest Action: Passed out of House Health and Human Services with an amendment 21 to 0 on Tuesday.

HF 537 - Authorized electronic monitoring in nursing facilities

Latest Action: Passed out of House Health and Human Services with an amendment 20 to 1 on Tuesday.

<u>SF 2063</u> - Establishing a nursing home administrator training pilot program Latest Action: Passed out of Senate Health and Human Services with an amendment 10 to 5 on Tuesday.

SSB 3001 - Insurance coverage for biomarker testing

Latest Action: Passed out of Senate Commerce with an amendment 16 to 0 on Tuesday.

HSB 573 - Assaults on health care providers

Latest Action: Passed out of House Judiciary 20 to 0 on Thursday.

JANUARY 8 – First day of session.

JANUARY 9 – The Governor's Condition of the State address. Governor Reynolds will discuss her budget and policy priorities.

FEBRUARY 16 – *First Funnel*. Final date for Senate bills and joint resolutions to be reported out of Senate committees and House bills and joint resolutions out of House committees.

MARCH 15 – Second Funnel. Final date for Senate bills and joint resolutions to be reported out of House committees and House bills and joint resolutions out of Senate committees.
